*This budget calls for Elimination of funding to states for Councils on Developmental Disabilities, independent living services, and traumatic brain injury services to be replaced with a new "innovation" program with less than half of the funding for the three programs.

**"No funds are requested for the Supported Employment State Grants program. The Administration recognizes that supported employment can be an effective strategy in assisting individuals with the most significant disabilities to obtain competitive employment in integrated settings. However, the Administration believes that a separate supplemental grant program is not necessary for the provision of supported employment services and the proposed elimination would reduce unnecessary administrative burden and streamline program administration at the Federal and State levels."
