Who should complete the online credentialing / proxy form?

The chapter's board president or vice president is authorized to out the online form.

If our chapter does not complete the online form, will the votes automatically be given to the state chapter?

No. State chapters cannot automatically appropriate the votes of local chapters in their state. If you missed the deadline to credential, the President of your chapter will be able to act as a representative. If the President is not able to attend, they may send their designee with a written proxy.

When is the deadline for completing the online form?

We ask that all chapters complete their online credentialing form on or before **Friday, October 26th, 2018 @ 5pm.**

What if I complete the form and then need to make a change?

Simply use your assigned user name and the password you created to login to your chapter specific form. Make sure to save any changes that you make. A new confirmation e-mail will be sent when you click submit.
